<b>Total Window Area</b>	Windows of same performance may be grouped together. For window film and/or screen, group like windows by direction. Decorative glass may include door glass, side lights, skylights etc.

High performance windows must be labeled by the National Fenestration Rating Council (NFRC) as achieving a Solar Heat Gain Coefficient (SHGC)  $\leq .50$  and a U-value  $< .75$  Window film and/or window screen must have a SHGC of  $\leq 0.40$  or a SC (Shading Coefficient) of  $\leq 0.45$  and must be installed on all east, west and south facing windows. Factory tint windows meeting the SHGC of  $\leq 0.40$  or a SC of  $\leq 0.45$  must also be rated by NFRC. Decorative glass is exempt provided its total area does not exceed 15% of the total glass area of the home. If performance of the window is in doubt, builder has the burden of proof in verification of window performance.
